 - i. Mayor Harvey noted the Town will lose \$11,000 in street aid funding and noted the Town will tap into the street aid funds for street lights for 1 year. The Town of Odessa uses those funds for street lighting, snow plowing & police coverage.

 - iii. It was determined that she should apply for \$40,000 to cover any additional costs.
