The monies will be used towards structural repairs in the basement, belfry tower leak, point repair to the bricks, gutter repairs and minor brick sidewalk repairs.
- Mayor Smith will be contacting the town solicitor to move forward with demolishing the abandoned house at 405 Main Street. Residents once again expressed safety concerns over the property.
- A resident also inquired as to whether a traffic study can be done on the proposed Osbourne Street development since the project does not meet the threshold of what DelDOT requires to perform a study.
