VII. Old Business

a. 405 Main Street Update - Mayor Smith has received (3) competitive bids for the demolition of the house, attached hereto as Attachments C, D & E (1-page estimates each). The estimates ranged from \$32,000.00 to \$57,570.00. The lowest bid had a contingency that if asbestos was found inside, there would be additional fees. Mayor Smith recommended that we go with a company that does not have a contingency. The bids were inclusive of demolishing the structure, hauling away debris, pumping and abandoning the septic system, removing asbestos siding, backfilling the basement with clean fill and covering with topsoil and grass seed. Next steps will be to schedule the demolition and contact the owners as a courtesy to let them know if there is anything they would like to remove from the house prior to it being demolished. The Mayor is hopeful that it will be demolished by Christmas in Odessa.

b. American Rescue Act Funding – Mayor Smith provided a brief overview of the ARPA funding in the amount of \$130,051.50 that the Town of Odessa received, attached hereto as Attachment G (1 page accounting and 4 letters). He provided an accounting of expenditures to date along with projected expenditures for projects already approved by council. The funding is use it or lose it money. We have four non-profits in town (Corbit

Calloway Library, Historic Odessa Foundation, Women's Club and the Odessa Fire Company) which have all provided documentation to show substantial losses due to Covid. Documentation was provided to council for consideration of a reimbursement for loss of income. When a monetary distribution is determined, it was suggested by the group attorney (Barnes & Thornburg LLC) that each of the non-profit organizations signs a release stating that if the Federal government rejects the disbursements, the funds will be returned by each organization. Council members will have the remainder of the month to look over the documentation and it will be discussed under old business at the next regularly scheduled meeting.

- b. Town Solicitor Barrett Edwards Mayor Smith introduced the town solicitor who was asked to attend by town residents. He provided an overview of the services that he provides to town council and thereby the residents. He reviewed the roles of town council, the planning commission, and the board of adjustment. He gave a general overview of the development process and discussed the different types of approvals that come before a public body such as zoning issues, conditional uses and special exception approvals etc. He explained that a subdivision approval is different; it's a check the boxes situation. If the code allows it, it gets approved. Mike Hoffman recently contacted him for an administrative subdivision for the property owner of 211 High Street. For this request, if the zoning code allows the rearrangement of the lot lines and the new orientation still meets code, then it moves forward. In regards to the proposed Osbourne Street subdivision, the board of adjustment holds the power at the moment since the developer has requested variances for overall lot size, lot width, location of homes closer to the street, and setbacks for a nonconforming barn and house. The board will be asked to make a decision based on all the evidence provided. Citizens will then have an opportunity at the public hearing to make their voices heard. After the board of adjustment, the project will be sent back to the planning commission and finally back to town council for final approval - whether it's the original plan of 15 homes or the new proposed plan. The planning commission has an opportunity during the subdivision process to ask for concessions on things that the town deems important or to address concerns. The developer could always deny the requests if it's not required in the code. The planning commission takes a role of making recommendations and then moves them forward to town council for final approval. They have no final decision-making abilities; town council does. Town council will have final approval to determine if the project meets all the requirements of the code. He made note that for municipalities, the maps and the text of the Comprehensive Plan has the force of law. The town thanks Mr. Edwards for coming and addressing the publics questions and concerns.
