VIII. New Business

a. American Rescue Act Funding – Three of the four non-profits that received ARPA grants have provided the requested accounting of funds. The Women's Club used the grant monies to replenish their scholarship account and were able to provide (5) \$2,500 scholarships. The Historic Houses of Odessa used the funds to pay quarterly payroll taxes. The Corbit Calloway Memorial Library used the funds on payroll, upgrading their security system and repairs to their automatic door which they were unable to do during Covid due to revenue loss.

Mayor Smith requested additional ARPA monies to perform much needed repairs to Old Academy.

3. Detail Stone Works – Old Academy Brick Work, attached hereto as Attachment E (1-page estimate)

MOTION BY LENNY AGUILAR, SECONDED BY YENI OCAMPO, TO APPROVE THE ESTIMATE FROM DETAIL STONE WORKS IN THE AMOUNT OF \$9,500.00 FOR BRICK REPAIRS TO THE OLD ACADEMY BUILDING, WALKWAY AND BELL TOWER.

b. Front Street Repaving Project - State Senator Stephanie Hansen along with State Representative Kevin Hensley have graciously agreed to provide funding from their Community Transportation Fund (CTF) to repave a section of Front Street in Odessa stretching from Main Street to High Street. Mayor Smith was tasked with getting bids from DelDOT approved contractors. Bids were received from Adel, Cirillo Bros and Austin & Bednash, attached collectively hereto as Attachment F (3 individual quotes) with prices range from \$29,982.50 to \$54,379.50 for the same project. Council was tasked with approving one of the three bids. Once approved, the town secretary will follow thru with the State to request the monies from the CTF fund. There is no necessity to have a public hearing on this matter as the funds will not be coming from the taxpayers, rather state funding will be used.

MOTION BY YENI OCAMPO, SECONDED BY LENNY AGUILAR, TO APPROVE THE ESTIMATE FROM A-DEL CONSTRUCTION CO, INC IN THE AMOUNT OF \$29,982.50 (4-PAGE PROPOSAL) TO REPAVE FRONT STREET FROM MAIN STREET TO HIGH STREET.

c. Memorial Park Porta-Potty Rental – The current contractor did not submit a renewal contract for this upcoming season. Three quotes were obtained from local businesses. The best quote came from A-1 Sanitation Services, attached hereto as Attachment G (1-page quote) with a total price of \$787 to include bi-weekly service from March – Nov and a one-time delivery fee.

He had considered increasing property taxes this year but would rather wait until New Castle County completes their assessments and comes back with their new property values to see where we stand before moving forward with that.

The requirements for this position would be an approximately (3) hour training session on Thursday, March 28, 2024 @ 2:00 PM at the Department of Elections Warehouse in New Castle and to work the day of the election here at town hall from 11 AM-8:30 PM. Pay for this position would be \$200. Please contact the town secretary as soon as possible if you would be interested and available.
