  - Treasurer Sheats reviewed various expenses on the balance sheet. In the Odessa Community Account, the deposit consisted of rental income. Expenses consisted of normal operating expenses. In the PNC Operating Account, the deposit consisted mainly of back property tax payments and JP court fees. Expenses consisted of normal operating expenses with the exception of a payment to the Town of Middletown in the amount of \$1,500.00 for town-wide leaf removal and Boyer & Boyer in the amount of \$6,850.00 for our yearly audit. Total assets are \$682,001.99.
- b. Balance Sheet / Profit & Loss as of 1-31-25, attached hereto as Attachments C & D (3-page reports)
  - Treasurer Sheats reviewed various expenses on the balance sheet. In the Odessa Community Account, expenses consisted of normal operating expenses. In the PNC Operating Account, deposits consisted of back property tax payments, transfer taxes and JP court fees. Expenses consisted of normal operating expenses with the exception of payment to Page Precision for snow removal at town hall. In the Municipal Street Aid Account, expenses included payment to Austin & Bednash in the amount of \$1,000.00 for town-wide snow plowing. Total assets are \$677,835.57.

  - Mayor Smith reported that the auditors found all the town records were in order, reasonable, accurate and complete. He stated that we went over budget approximately \$23,000.00 on items that are really out of our control such as street lighting, insurance, trees and attorney's fees. He will work closely with Treasurer Sheats on the upcoming budget in May. The Mayor admitted once again that he made a mistake in September by being one of two signers on a check made payable to himself for \$17.99 for reimbursement of a key box for the town secretary's office. He stated that he should have had Councilwoman Ocampo and Treasurer Sheats sign the check versus himself.
