High Street Widening and Repaving Project - State Senator Stephanie Hansen along c. with State Representative Kevin Hensley have graciously agreed to assist with obtaining funding from the states Community Reinvestment Fund (CRF) to widen and repave a section of High Street in Odessa stretching from Fourth Street to Front Street. Mayor Smith was tasked with getting bids from DelDOT approved contractors. Bids were received from A-Del, Austin & Bednash, Cirillo Brothers and Diamond Materials, attached collectively hereto as Attachment E (4 individual quotes including a bid request and comparative spreadsheet) with prices range from \$238,088.25 to \$282,690.00 for the same project. Council was tasked with approving one of the four bids so that we can move forward with requesting the funding. After a bid is approved, the town secretary will follow through with the State to request the monies from the CRF fund. There is no necessity to have a public hearing on this matter as the funds will not be coming from the taxpayers, rather state funding will be used. The Mayor provided assurance that he will meet with the contractor directly prior to starting the project and will work closely with any residents along High Street whose properties may be affected by the street widening.

Miscellaneous:

Mayor Smith informed council that on Thursday, February 20, 2025 one of the renters upstairs at the Old Academy (Magic & Main) called 911 for an odor of smoke in the building. The Fire Company came out and discovered a burning odor in the basement and immediately shut down both heaters. Chesapeake Utilities came out and verified that there were no gas leaks coming from any of the lines. The following day our heating contractor Hawks & Company assessed the situation and discovered that the unit that services the left side of the building (council chambers) had a cracked heat exchanger. The unit was over 15 years old. Mayor Smith approved an estimate in the amount of \$9617.00 to install a whole new furnace. The new furnace was installed on Friday, February 28, 2025. The money will come from the Odessa Community Account (Old Academy account).
