- b. Treasurer Sheats reviewed various expenses on the balance sheet. In the Odessa Community Account, the deposits consisted of rental income. Expenses consisted of normal operating expenses with the exception of two payments to Hawks & Company totaling \$10,342.00 for the new furnace installed on the council chamber side of the building. In the PNC Operating Account, the deposits consisted of property tax payments, franchise fees and JP court fees. There was also a large deposit from the State of Delaware in the amount of \$70,918.99 which was subsequently disbursed as agreed to the Odessa Fire Company for traffic safety vehicles. Expenses consisted of normal operating expenses. In the Municipal Street Aid Account, expenses included a payment to Austin & Bednash in the amount of \$1,000.00 for town-wide snow plowing on 2/12/25. Total assets are \$647,648.13.

XI. Public Comment

- Jim Grant (103 High Street) asked if the Town will be using the assessment figures from New Castle County. He asked because his properties have been assessed at \$640,000 and he said he is not paying taxes on that.
- Mayor Smith stated that we are waiting on the County to provide us with official numbers for our reassessment. We have received some preliminary information, but the final numbers have not been provided. Once we are provided the final figures, we will work on making the tax figures tax neutral as best we can. That means that the residents will be paying close to what they were before. The tax rate will need to be adjusted as the current rate of \$0.25 per \$100 of assessed value will no longer work. The Town is required by our Charter to post the assessment data by May 1st of each year.
- The town secretary added that our Charter states that we must use New Castle County's assessed values to determine our town taxes.
- Kevin Caneco, New Castle County Councilman, stated that the reason why we are having the delay in getting the final assessment figures is because the County extended the appeals process two weeks until March 31, 2025 for those owners who filed formal appeals. He stated that the County's budget will be delayed, and that the Town may be able to use last year's assessments for this year's budget, but our town solicitor would have to make that determination. He stated that at the end of the day it will all be revenue neutral.
- Mayor Smith asked whether the County would postpone the assessment for another year, to which Kevin stated he does not believe they will. He added that the State Legislature now passed a law that we are to be reassessed every 5 years to make it a more "muscle memory" process.
- Kevin invited the community to a monthly meeting on April 23, 2025 @ 6:30 PM at the Appoquinimink Library on Main Street in Middletown where he and Councilman Dave Carter will be available to answer any additional questions about the reassessment or any other county-wide issues.
- Meghan Mahoney (220 Cantwell Avenue) invited the community to a yard sale event hosted by the Women's Club of Odessa on Saturday, April 12, 2025 from 8:00 AM 2:00 PM located at 205 Main Street here in Odessa. All proceeds from the sale will go to the Stockley Center and the Carol Pearl Scholarship.
