- VI. Treasurer's Report
  - a. Balance Sheet / Profit & Loss as of 7-31-25, attached hereto as Attachments A & B (3-page reports)

Treasurer Sheats reviewed various expenses on the balance sheet. He reported that the town clerk was unable to access the M&T Sweep Investment Account and will reconcile the account next month. In the Odessa Community Account, the deposit consisted of rental income. Expenses consisted of normal operating expenses and included a service call for the air conditioner for town hall. In the PNC Operating Account, deposits totaled \$280,283.92. The bulk of the deposit came from the State of Delaware in the amount of \$238,088.00 from the Community Reinvestment Fund to be used for the widening and repaying of High Street from Fourth to Front Street. The remainder came from property tax payments, permit fees, franchise fees and transfer fees. Expenses consisted of normal operating expenses and included a payment to First State Inspection in the amount of \$3,280.00 for the zoning administrators' review of the Odessa Commons Planned Neighborhood Development, which the town has already received reimbursement for by the residential builder K. Hovnanian Homes. There was also a payment to Tree Inc. in the amount of \$2,950.00 for the removal of a large street tree in front of 307 High Street and miscellaneous Memorial Park tree trimming. Total assets are \$907,319.67.

#### VIII. Old Business

a. High Street Widening and Repaving Project – Mayor Smith informed council that the town received the \$238,088.00 from the State of Delaware's Community Reinvestment Fund. He stated that the project will begin after he has met with the property owners on High Street that will be directly affected by the approximately 7 foot widening of the roadway.

- Jonathan Contant, Land Planning Manager with K. Hovnanian Homes, provided the handout "Odessa Commons" dated August 4, 2025, attached hereto as Attachment M (12-page handout) to all in attendance.
- Charlie Barnett, Principal Engineer with Morris & Ritchie Associates, presented an overview of the Odessa Commons Planned Neighborhood Development (PND). He discussed overall street design, entrance locations, public utility partners, and general landscape design. Internal streets in the residential portion will be turned over to the town when the project is complete as per our code. The builders are proposing an ornamental fence consisting of masonry pillars and aluminum fencing along the entire frontage of Main Street. He is confident that DelDOT will require a multi-use shared use path to run along Main Street. Internal streets will be flanked with sidewalks that will tie into the shared use path. The developers are proposing a ½ acre of land that they are dedicating to town to be used for parking for the Memorial Park. He stated that the proposed park entrance has not been designed yet or brought before DelDOT, but they have looked at the possibility of using the existing pull off area and feel it will comply with all of DelDOT's requirements.
- Jonathan Contant reviewed the handout they provided, focusing first on parking requirements. K. Hovnanian is proposing 2 ½ parking spaces per residential unit to alleviate the need to park in the street. This is in addition to the two-car garages that each home comes with. He then discussed the fiscal impact to the town by way of annual taxes generated, transfer taxes generated, and impact fees received. Pam Scott reviewed the fiscal impact that will be generated by the proposed commercial portion of the project.
- Councilman Freeman asked questions about the proposed entrances and expressed concern over the additional traffic that will be generated on Main Street/Rt. 299.
- Charlie Barnett provided the Mayor with a rough concept of a dedicated parking area for the Memorial Park utilizing the existing pull off.
- Councilman Aguilar asked if the developers had an intention to tie into Mechanic Street. K. Hovnanian Homes stated they had no plan at this time to tie into Mechanic Street.
- Councilwoman Ocampo asked if sidewalks would be installed on both sides of Main Street. The developer stated that they will be installed only on their side of the roadway.
- The Mayor then opened the floor to public comment.
  - Shelley Perry (Main Street resident) wanted to discuss the frontage. She wanted to know how much square footage is allotted for trees and shrubs. Charlie Barnett explained that there will be the road (Rt. 299/Main Street), then the DelDOT shared use path, then the aluminum fence with masonry pillars and then behind the fence in the commercial portion, the PND dictates the required number of plantings. He stated that the residential portion did not provide much guidance on what needs to be on the residential side. Shelley stated that in the Planning Commission meeting it was stated that there would be privacy trees in front of the townhomes that are by the main road. Mike

Irons, K. Hovnanian Homes Division President, stated that they will work with MRA to make sure that there is enough room to plant a nice buffer of trees.

O The town secretary read into the record an email provided by Amanda Russell, Planning Commission Chair, attached hereto as Attachment N (2-page email), regarding concerns about the proposed entrance to the donated land for the parking lot which were provided by New Castle County Councilman Dave Carter and DelDOT. Jonathan Contant discussed sight distances and stated that DelDOT will provide final determination on what can be done with the parking area.
