- I. Call to Order & Pledge of Allegiance The meeting was called to order at 7:02 PM.

MOTION BY LIONEL HYNSON, SECONDED BY LENNY AGUILAR TO EXCUSE YENI OCAMPO FROM THE NOVEMBER 3, 2025 MEETING OF MAYOR & COUNCIL.

III. Approval of Minutes

a. Minutes: Regular Meeting of Mayor & Council 10-6-25

MOTION BY JOHN FREEMAN, SECONDED BY LENNY AGUILAR TO APPROVE THE MINUTES FROM THE OCTOBER 6, 2025 MEETING OF MAYOR & COUNCIL.

- V. Treasurer's Report
  - a. Balance Sheet / Profit & Loss as of 10-31-25, attached hereto as Attachments A & B (*3-page reports*)
  - b. Treasurer Sheats reviewed various expenses on the balance sheet. He reported that the town clerk did not reconcile the M&T Sweep Investment Account again this month as she is currently seeking advice from the town accounting firm on how to record transactions on this account. In the Odessa Community Account, expenses consisted of normal operating expenses. In the PNC Operating Account, deposits totaling \$12,933.46 consisted of property tax payments, permit fees and traffic fines. Expenses consisted of normal operating expenses with the exception of a payment to Cat's Meow in the amount of \$343.75 for town hall replicas to sell, a payment to the town's engineering firm i3a LLC in the amount of \$4,500.00 for the right of way survey for High Street, and a payment to Masten Electric in the amount of \$1,100.00 for upgrades to add a dedicated receptacle for the Holiday tree outside town hall. He reported that to date we have received \$300.00 in donations towards the holiday tree electrical upgrade. Total assets are \$974,571.70.

- a. High Street Widening and Repaving Project
  - Mayor Smith stated that council had heard the comments and suggestions made by the public on the project at the 6:00 PM public hearing. He asked council if they requested any further action on the project. No further action was taken, and the project will continue to move forward.
  - The town secretary submitted a first accounting for the project, attached hereto as Attachment C (4-page accounting), reflecting expenditures from grant acceptance to October 31, 2025.

- c. Town Secretary Position
  - Mayor Smith informed council that the town secretary position was posted, and the posting closed on October 31, 2025. There has been one applicant for the position. He requested that the Mayor, along with one council member and the current town secretary, be allowed to conduct an interview, and if the person possess the qualifications of the position, extend an offer of employment so the applicant could be installed at the December town council meeting.

MOTION BY LIONEL HYNSON, SECONDED BY LENNY AGUILAR, TO ALLOW THE MAYOR ALONG WITH ONE COUNCIL MEMBER AND THE EXISTING TOWN SECRETARY TO CONDUCT AN INTERVIEW AND EXTEND AN OFFER OF EMPLOYMENT IF THE APPLICANT MEETS THE QUALIFICATIONS.

- d. Old Academy HVAC Contract
  - Mayor Smith stated that in the beginning of October he had the town secretary send out letters to three HVAC contractors for a proposal to service the town's two HVAC units. The town requested pricing from Hawks & Company (our current contracted provider), Bendler Heating & Cooling, and Crouse Brothers (contractor for Historic Homes of Odessa). Our existing HVAC contractor, Hawks & Company, upped their

price from \$746.00 a year to \$1,024.00 a year with a 3% increase built into the contract each year, attached hereto as Attachment G (5-page proposal). They also increased their hourly rate for repairs and added a new \$125.00 truck charge. Crouse Brothers came in second highest at \$950.00 year, attached hereto as Attachment H (1-page proposal) and Bendler Heating & Cooling was the most reasonable price coming in at \$792.00 year with a 20% discount off all repairs, attached hereto as Attachment I (2-page proposal).

MOTION BY LENNY AGUILAR, SECONDED BY JOHN FREEMAN, TO APPROVE THE HVAC MAINTENANCE CONTRACT WITH BENDLER HEATING & COOLING FOR THE TOWN OF ODESSA.

- e. High Street Widening and Repaving Project
  - The town's engineering firm, i3a LLC, provided a proposal for an Erosion & Sediment Control Plan in the amount of \$9,990.00, attached hereto as Attachment J (2-page proposal), to show proposed measures to mitigate sediment-laden runoff during construction so that they can be submitted to New Castle County Conservation District for review and project approval.
  - Councilman Aguilar asked if engineering fees were an eligible grant expense. The town secretary verified that preconstruction costs, which include the development of plans and specification for the capital project, are eligible grant expenses.

MOTION BY LIONEL HYNSON, SECONDED BY LENNY AGUILAR, TO APPROVE THE PROPOSAL PREPARED BY I3A, LLC IN THE AMOUNT OF \$9,990.00 FOR EROSION & SEDIMENT CONTROL PLANS REQUIRED FOR SUBMISSION TO NEW CASTLE COUNTY CONSERVATION DISTRICT FOR THE HIGH STREET WIDENING & REPAVING PROJECT.
